ADDITION OF PUBLIC FOOTPATHS W133 AND W133A BRAUNSTONE TOWN DEFINITIVE MAP MODIFICATION ORDER 2018

This Order is made by Leicestershire County Council (hereinafter called "the authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 (hereinafter called "the Act"), because it appears to the Leicestershire County Council (hereinafter called "the surveying authority") that the Definitive Map and Statement for the County of Leicestershire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) namely the discovery by the surveying authority of evidence which (when considered with all relevant evidence available to the surveying authority) shows that rights of way which are not shown in the map and statement subsists or are reasonably alleged to subsist over land in the area to which the map relates being rights of ways such that the land over which the rights subsists are public footpaths within the Parish of Braunstone and the District of Blaby as shown by broken black lines with short intervals on Plan No.M1010 annexed hereto and described in the Schedules hereto.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The Authority hereby order that:-

- 1. For the purpose of this Order the relevant date is 7th February 2018.
- The Definitive Map and Statement for the County of Leicestershire shall be modified as described in Part I and Part II of the Schedules and shown on the map attached to the Order.

3. This Order shall take effect on the date it is confirmed and may be cited as the "Leicestershire County Council (Addition of Public Footpaths W133 & W133a, Braunstone Town) Definitive Map Modification Order 2018."

MODIFICATION OF DEFINITIVE MAP

Description of Public Footpath W133 to be added

A Footpath to be known as W133 in the Parish of Braunstone and the District of Blaby shown by a broken black line with short intervals on Plan No.M1010 which extends from point "A" on the Plan situated at a junction with Watergate Lane at Grid Reference 45521 30127 in a generally north-north-west then north-north-easterly direction for a total distance of approximately 265 metres to point "B" on the Plan situated at a junction with Public Footpath W133a (also added by this order) and at Grid Reference 45517 30152 and then continues in a generally east-north-easterly direction for a further distance of approximately 70 metres to point "C" on the Plan situated at the Lubbesthorpe Brook and a junction with Public Footpath W9 at Grid Reference 45523 30155.

The footpath has a width of 1.8 metres.

Description of Public Footpath W133a to be added

A Footpath to be known as W133a in the Parish of Braunstone and the District of Blaby shown by a broken black line with short intervals on Plan No.M1010 which extends from point "B" on the Plan situated at a junction with Footpath W133 (also added by this Order) at Grid Reference 45517 30152 in a generally north then west–north-westerly direction following the perimeter of a flood basin for a distance of approximately 260 metres to point "D" on the Plan situated at a footbridge adjacent to Lubbesthorpe Way and at Grid Reference 45499 30168 and then continues in a generally northerly direction parallel to the road for a further distance of approximately 60 metres to point "E" on the Plan situated at a junction with Public Bridleway W5 and at Grid Reference 45499 30174.
